UPDATED PROTOCOLS FOR THE ENTRY TO THE PHILIPPINES OF TRAVELERS FROM GREEN, YELLOW, AND RED LIST COUNTRIES

The Philippine Embassy in Seoul wishes to share with the public Resolution No. 144-A, s. 2021 dated 14 October the IATF (Inter-Agency Task Force for the Management of Emerging Infectious Disease), which streamlines and codifies the testing and quarantine protocols for international arriving passengers in all ports of entry in the Philippines, as follows:

GREEN LIST COUNTRIES/JURISDICTIONS/TERRITORIES

"Green List" countries/jurisdictions/territories are those classified by the IATF as "Low <u>Risk" countries/jurisdictions/territories</u>. Subject to the review on the infection rates for fully vaccinated arriving international travelers and its operational framework on the fourteenth date from effectivity of IATF Resolution No. 144-A, s. 2021, the protocols for "Green" List countries/territories/jurisdictions in all ports of entry in the Philippines shall be as follows:

- A. General guidelines:
 - For fully vaccinated foreign nationals: a negative Reverse Transcription Polymerase Chain Reaction (RT-PCR) test shall be required to be taken within seventy-two hours (72) prior to departure from the country of origin. Upon arrival, <u>no facility-based quarantine will be further required</u> but the passenger is enjoined to self-monitor for any symptoms until the fourteenth (14th) day with the first day being the date of arrival.
 - For fully vaccinated Filipinos, whether Overseas Filipino Workers or non-Overseas Filipino Workers: either of the following depending on the choice of the arriving international passenger:

- a) Facility-based quarantine until the release of a negative RT-PCR test taken in the quarantine facility upon arrival; or
- b) When a negative RT-PCR test was taken within 72 hours prior to departure from the country of origin, no facility-based quarantine shall be required but the passenger is enjoined to self-monitor for any sympotoms until the fourteenth (14th) day with the first day being the date of arrival.
- For unvaccinated, partially vaccinated, or individuals whose vaccination status cannot be independently validated, and those who are vaccinated but failed to comply with the above test-before-travel requirements:
 - a) Facility-based quarantine until the release of a negative RT-PCR test taken on the fifth (5th) day and self-monitor until the fourteenth (14th) day of arrival, with the date of arrival being the first day. Foreign nationals shall be required to secure hotel reservations for at least six (6) days.
 - b) Unvaccinated or partially vaccinated minor children traveling with their fully vaccinated parent/s or guardian/s shall be required to observe the quarantine protocols corresponding to their vaccination status. A parent/guardian shall accompany the child in the quarantine facility for the full term of the latter's facility-based quarantine period.
- B. All passengers, whether Filipinos or foreigners, merely transiting through a non-Green List country/jurisdiction/territory shall not be deemed as having come from or having been to said country/jurisdiction/territory if they stayed in the airport the whole time and were not cleared for entry into such country/jurisdiction/territory by its immigration authorities.
- C. The Bureau of Quarantine (BOQ) shall ensure strict symptom moniroting while in the facility quarantine. If found positive, he/she shall follow the prescribed isolation protocols. Upon completion of such quarantine, the BOQ shall issue a Quarantine Certificate indiciating therein the individual's vaccination status.

YELLOW LIST COUNTRIES/JURISDICTIONS/TERRITORIES

<u>'Yellow List" countries/jurisdictions/territories are those classified by the IATF as</u> <u>"Moderate Risk" countries/jurisdictions/territories, upon recommendation of the sub-</u> <u>Technical Working Group on Data Analytics.</u> The protocols for "Yellow" List countries/jurisdictions/territories in all ports of entry in the Philippines shall be as follows:

A. Fully vaccinated individuals coming from "Yellow" List countries/territories/jurisdictions <u>need to undergo facility-based quarantine until</u> <u>the release of their negative RT-PCR testing taken on the fifth (5th) day.</u> After which, they shall be required to undergo home quarantine until their tenth (10th)

day, with the day of arrival being the first day. The BOQ shall ensure strict symptom monitoring while in the facility. Foreign nationals shall be required to secure their own pre-booked accommodation of at least six (6) days.

B. Unvaccinated, partially vaccinated, or individuals whose vaccination status cannot be independently verified/confirmed by Philippine authorities as valid and authentic coming from "Yellow" List countries/territories/jurisdictions <u>shall be</u> required to undergo facility-based quarantine until the release of their negative <u>RT-PCR testing taken on the seventh (7th) day.</u> After which, they shall be required to undergo home quarantine until their fourteenth (14) day, with the day of arrival being the first day. The BOQ shall ensure strict symptom monitoring while in the facility. Foreign nationals shall be required to secure their own prebooked accommodation of at least eight (8) days.

RED LIST COUNTRIES/JURISDICTION/TERRITORIES

"Red" List countries/jurisdictions/territories are those classified by the IATF as "High Risk" countries/jurisdictions/territories, upon recommendation of the sub-Technical Working Group on Data Analytics. The inbound international travel of all persons, regardless of "Red" vaccination status. coming from who have been to or List countries/jurisdictions/territories within the last fourteen (14) days prior to arrival to any port of the Philippines shall not be allowed. Only Filipinos returning to the country via government-initiated repatriation, non-government-initiated repatriation, and Bayanihan Flights may be allowed entry subject to the following entry, testing and quarantine protocols:

A. All arriving travelers shall undergo fourteen (14) days quarantine upon arrival. The first ten (10) days of which shall be observed in a quarantine facility, with the remainder to be completed under home quarantine in their respective local government units of destination;

- B. RT-PCR testing shall be conducted on the seventh (7th) day, with Day 1 being the day of arrival. Notwithstanding a negative test result, the arriving traveler shall complete the facility-based quarantine period of ten (10) days;
- C. The BOQ shall ensure strict symptom monitoring while in the facility quarantine for 10 days;
- D. All passengers, whether Filipinos or foreigners, merely transiting through a Red List country/jurisdiction/territory shall not be deemed as having come from or having been to said country/jurisdiction/territory if they stayed in the airport the whole time and were not cleared for entry into such country/jurisdiction/territory by its immigration authorities;
- E. Upon arrival in the Philippines, passengers covered by the immediately preceding paragraphs shall comply with existing testing and quarantine protocols.

RED LIST as of 14 October 2021	
Romania	

All countries/jurisdictions/territories not on current Red or Green Lists are automatically on the Yellow List. All lists will be updated regularly.

The Embassy wishes to note that <u>South Korea belongs to the Yellow List</u>. Passengers who will travel from South Korea to the Philippines are requested to closely read and follow the Yellow List guidelines.

All incoming travelers to the Philippines are required to register in the One Health Pass (OHP) system as mandated by IATF Resolution No. 135 dated 26 August 2021. Travelers who wish to apply for a vaccination pass may do so through the OHP website by selecting the option "Apply Vaccine Pass" and uploading the vaccination certificates. The OHP website is https://onehealthpass.com.ph/. For the purposes of validating vaccination status, the following shall be observed:

- A. (i) OFWs and their spouse, parent/s, and/or children traveling with them vaccinated in the Philippines or abraod, (ii) non-OFWs vaccinated in the country of abroad, and (iii) foreigners vaccinated in the Philippines either their VaxCertPH digital vaccination certificate, BOQ/World Health Organization-issued International Certificate of Vaccination or Prophylaxis (ICV), or the national/state digital certificate of the foreign government where they were vaccinated, which has accepted VaxCertPH under a reciprocal agreement unless otherwise permitted by the IATF.
- B. For foreign nationals vaccinated abroad: WHO-issued ICV, or the national/state digital certificate of the foreign government which has accepted VaxCertPH under a reciprocal arrangement unless otherwise permitted by the IATF.
