STANDARD CONTRACT

This Contract is executed and delivered on 23 September 2023 at the Embassy of the Republic of Philippines in Seoul, between the Embassy of the Republic of Philippines in Seoul, with Non-profit Business registration number 213-84-10180, represented by MS. MARIA THERESA B. DIZON-DE VEGA, Ambassador of the Embassy of the Republic of Philippines in Korea, with its office at 80 Hoenamuro, Yongsan-gu, Seoul, Republic of Korea (hereinafter referred to individually as "the Client") and Lus Korea with Business registration number 128-36-97909, represented by MR. PARK SEONGGWANG, with its office at 1117-41 Baekseong-dong, Na-dong, Ilsandong-gu, Goyang-si, Gyeonggi-do (hereinafter referred to individually as "the Supplier") and jointly as the "Parties".

- 1. Objective. That Client agrees to avail the services of the Supplier for the supply and installation of car window tint, based on the technical specifications in the TERMS OF REFERENCE prepared by the Client. The Terms of Reference to this Contract constitute an integral part of this Contract.
- 2. Warranty of Capacity. That the Supplier is a business entity having the necessary capacity to deliver the product required of by the Client.
- 3. Payment. The total contract price for the supply and installation of car window tint is KRW 1,540,000 (VAT included). Payment method: 100% cash:
 - a. Payment shall be made within seven (7) days after fulfillment of the contract and receipt of invoice via bank deposit.
 - b. The payment of the agreed price will be made in the form of cash for the agreed amount, by transferring from the bank account of the Client to the bank account of the Supplier, as follows:

- 4. Compensation rate for late completion or delivery. The Supplier shall pay 1/1000% of the contract amount per day of delay in the completion of the installation of car window tint under this Contract.
- 5. Warranty on Defects. The Supplier must take immediate action when a defect occurs. The Defect Warranty Liability Period will run for a period of one (1) year from the completion date of the installation of the car window tint. Damages not considered under manufacturer's defects are not covered by the warranty.
- 6. **Settlement of Disputes.** Both parties shall exert their best efforts to amicably settle any dispute, controversy or claim arising out of the contract, or the breach, termination, or invalidity thereof.

- 7. **No Employer-Employee Relationship.** Nothing in the contract is intended or shall be deemed to create any employment, partnership, agency or joint venture between the parties.
- 8. **Observation of Laws.** Both parties, including all subcontracted parties if mutually agreed upon, shall comply with the provisions of relevant laws and regulations, such as the Construction Business Act, in the performance of the contract.
- 9. **Immunity.** Nothing in the contract shall be construed as a waiver by the Client of its diplomatic or consular immunity recognized under international law and national laws of the Republic of Korea.
