

# CONTRACT

The Contract for the Short-Term Lease of One (1) Vehicle with Driver for Official Use of the Embassy ("Contract") is entered into between the **EMBASSY OF THE REPUBLIC OF THE PHILIPPINES** in Seoul ("*Embassy*"), with non-profit business registration number 213-84-10180 with its office at 80 Hoenamu-ro, Yongsan-gu, Seoul 04346, represented by Ambassador Maria Theresa B. Dizon-De Vega, and **AHN CHEOL-WOO JEJU BENZ** ("*Company*") with business registration number 743-05-01381 with its office at Yeonmi-gil, Jeju-si, Jeju-do represented by Mr. An Chul Woo.

## *I. Scope of Work*

The Embassy shall rent one (1) vehicle with driver on 29 May to 03 June 2023 for the Philippine delegation (3 persons). This will also include airport pick-up and drop-off during the arrival and departure of the delegation.

The contract price shall include driver, insurance coverage, fuel replenishment cost, and parking fees. The location of the accommodations and the meeting locations are within Jeju.

## *II. Expected Deliverables*

- a. The Company shall ensure that the vehicles assigned to the Embassy is in excellent condition. However, in an event that the vehicle breaks down,

- the Company will arrange for its immediate replacement without delays.
- b. The assigned vehicle shall include a driver, preferably can speak English language.
  - c. The assigned vehicle should be of year 2019 and onwards.
  - d. The Embassy is not liable for the maintenance of the company's vehicles. The Company shall be responsible for its vehicle's maintenance.

### **III. Vehicle Specifications**

Based on the number of people, the Embassy will require one (1) 6-seater van, which can comfortably seat 1 person in front, 2 persons in the middle 3 persons at the back, with luggage.
