SUPPLY AND INSTALLATION OF WINDOW TINT FOR THE OFFICIAL CAR OF THE EMBASSY

Terms of Reference

The Embassy intends to engage the services of a reputable Company for the application of car window tint for the newly procured official car of the Embassy.

I. Scope of Work

The Company shall supply and install the tint on the car window of the new official vehicle (2023 Mercedes Benz E350 Exclusive 4Matic) for the following windows:

1. Front Windshield
2. Front Door Glass
3. Rear Door Glass
4. Rear Vent Glass
5. Rear Windshield
6. Sunroof / Moonroof

II. Technical Specifications

The Embassy will require car window tints with the following:

1. Provides infrared heat rejection due to the absorptive nano-ceramic technology. Rejecting up to 66% of total solar energy and up to 66% of total solar energy and up to 95% infrared injection for optimal thermal comfort and reducing the feel of sun on the skin.
2. Tint should be made of high-quality nano ceramic coating so as to be signal-neutral and therefore do not interfere with the reception of mobile phones, navigation and other electronic devices in the vehicle.
3. Should be able to reduce 93% of the glare from sunlight with low visible light reflectivity and no mirror-like appearance to disrupt the view out.
4. Should come in 40% tint level for front windshield, and 20% tint level for rear windshield, front and rear door glass, rear vent glass, and sunroof.

III. Approved Budget for the Contract

The Approved Budget for the Contract (ABC) for the project is ONE MILLION FIVE HUNDRED FORTY THOUSAND WON (~~₩~~ 1,540,000), inclusive of all applicable government taxes and charges.

IV. Warranty

The service should come with at least one (1) year warranty from the Company. In case the film has a defect or starts peeling within the warranty period, the warranty will allow the Embassy to replace the tint free of charge.

V. Terms of Payment

Payment shall be made within seven (7) days upon completion of the supply and installation of the window tint and acceptance of the Embassy on the installation of the window car tint from the winning bidder.
