

CONTRACT

The Contract for the Procurement of Wireless Microphone System for Official Use of the Embassy (“Contract”) is entered into between the **EMBASSY OF THE REPUBLIC OF THE PHILIPPINES** in Seoul (“Embassy”), with non-profit business registration number 213-84-10180 with its office at 80 Hoenamu-ro, Yongsan-gu, Seoul 04346, represented by Ambassador Maria Theresa B. Dizon-De Vega, and **BEST PLUS** (“Company”) with business registration number 220-01-65977 with its office at 678-1 Yeoksam-gu, Gangnam-gu, Seoul represented by Mr. Hong Seong Hwan.

I. Scope of Work

The Company agrees to supply and deliver the wireless microphone system within thirty (30) days upon signing of this contract.
