Contract

Ms. Mishka Camulte (hereinafter referred to as "Party A") and the Philippine Embassy in Seoul (hereinafter referred to as "Party B") agree to a contract in relation to the Diplomatic Reception in Celebration of the 125th Anniversary of the Proclamation of Philippine Independence event as follows.

Article 1 [Purpose]

The purpose of this contract is to pursue mutual common interests by determining the necessary matters and the contents of business partnerships for "Party A" and "Party B" to make a contract.

Article 2 [Definition of Contract]

This contract means that "Party B" requested the following performances by "Party A" so that the event can proceed smoothly:

- 1. Umagang Kay Ganda (A Beautiful Morning)
- 2. Arem Dau Nara (Beatifuly Country)
- 3. Orange Colored Sky
- 4. Love You I do

Article 3 [Rental date and fee]

- 1. Event name: Diplomatic Reception in Celebration of the 125th Anniversary of the Proclamation of Philippine Independence
- 2. Schedule: from 15000H-2200H on Monday, 8th June 2023
- 3. Location: Grand Salon, Hyatt Hotel, 322 Sowol-ro, Hannam-dong, Yongsan-gu, Seoul
- 4. Professional fee: 600,000 Korean Won

Article 4 [Rental fees and penalties]

1. "Party B" must pay 100% of the professional fee to "Party A" within seven (7) working days from 8th June 2023, the contract date. Bank details are as follows:

- 2. When "Party B" cancels the confirmed performance of "Party A", "Party B" must notify "Party A" at least two days before the event date.
- 3. If "Party B" cancels the confirmed performance to "Party A" one day before the event date, "Party B" shall pay 30% of the penalty fee to "Party A".
- 4. Additional expenses due to the extension or additional song performances shall be in accordance with the criteria of Article 3 [Rental date and fee].
- 5. "Party A" shall pay taxes to the appropriate agencies.

Article 5. [Addendum]

1. Matters not prescribed in this Agreement shall be governed by general correlation practices.

- 2. In the event of a dispute between "Party A" and "Party B" regarding the performance of the contract, "Party A" and "Party B" shall primarily do their best to mediate the dispute based on the principle of good faith.
- 3. If it is deemed necessary to mediate a dispute, an arbitration proposal may be appointed under the agreement of both parties, and both parties respect the interpretation of the arbitrator.
- 4. In the case of filing a lawsuit because the dispute has not been resolved pursuant to the above paragraph 3, the Seoul Central District Court shall be shall be the exclusive jurisdiction court.
