CONTRACT

The Contract for the Supply and Delivery of 75th PH-ROK Commemorative Rollerball Pens for Official Use of the Embassy ("Contract") is entered into between the **EMBASSY OF THE REPUBLIC OF THE PHILIPPINES**in Seoul ("*Embassy*"), with its office at 80 Hoenamu-ro, Yongsan-gu, Seoul 04346, represented by Ambassador Maria Theresa B. I. Scope of Work
