

REQUEST FOR QUOTATION

Terms of Reference

The Embassy of the Republic of the Philippines intends to procure a 32-inch CCTV monitor display from a reputable supplier compatible with its existing CCTV system.

I. Background

The Embassy's CCTV System is currently installed in the Administrative Section. With the renovation of the executive offices, including the Administrative Section, the cabinet intended for the CCTV system allows for a larger monitor display.

II. Scope of Work

The Supplier shall deliver and install the new 32-inch CCTV monitor display in the Administrative Section.
