I. Term

III. Photographer Service Fee

The Supplier will charge the service fee ("fee") for the provision of the photos taken during the event performed by the Supplier for the performance of service contract as KRW 715,000 (VAT included).

IV. Copyright and Intellectual Property Rights

In consideration of the fees paid, the Supplier expressly assigns to the Embassy any copyright arising from the works of Supplier produces while Page 1 of 2

executing the contract. The Supplier may not use, reproduce, or otherwise disseminate or authorize others to use, reproduce or disseminate such works without prior consent from the Embassy.

V. Safety

The Supplier shall, at his/her/their own expense, be solely responsible for protecting its employees, sub-Photographers, material suppliers, and all other persons from risk of death, injury or bodily harm arising from or in any way related to the photo coverage services or the site where it is being performed.
