

CONTRACT

The Contract for Professional Photography Services for the submission of high-resolution photographs of Embassy-owned artworks ("Contract") is entered into between the **EMBASSY OF THE REPUBLIC OF THE PHILIPPINES** in Seoul ("*Embassy*"), with its office at 80 Hoenamu-ro, Yongsan-gu, Seoul 04346, represented by Ambassador Maria Theresa B. Dizon-De Vega, and **ALL ABOUT RELATIONS** ("*Supplier*"), with its office at 45 Yangcheon-ro 77gil, Gangeogu, Seoul represented by Mr. Sylar YW No.

I. Term

The term of this Contract shall commence on 23 April 2024 and terminated after sufficient quantity of photographs for each photograph are taken. Due to the money value of the artworks, the Supplier shall shoot the artworks at the Official Residence and shall bring its own equipment, including lighting.

II. Scope of Work

- a. Supplier shall dispatch one (1) photographer to the Official Residence on 23 April 2024 (Tuesday) to take photographs of the following artworks by Lenore RS Lim:
 - i. Waterscape
 - ii. Symbiosis
 - iii. Spirit to Survive
 - iv. Orchids
 - v. Ode to My Motherland
 - vi. Leaf 2
 - vii. Hydrangea on Calado Calligraphy
 - viii. Gingko 3
 - ix. Buried Treasures
 - x. Bougainvillea
 - xi. Bagumbayan
- b. After taking sufficient quantity of photographs, the Supplier shall send the original photo files taken on or before 12:00PM of 25 April 2024 (Thursday) to the Philippine Embassy either via e-mail or saved in USB drive.

III. Photographer Service Fee

The Supplier will charge the service fee ("fee") amounting to KRW 900,000 (VAT included) for the professional photography services for cataloguing of artworks performed by the Supplier.

IV. Copyright and Intellectual Property Rights

In consideration of the fees paid, the Supplier expressly assigns to the Embassy any copyright arising from the works of Supplier produces while executing the contract. The Supplier may not use, reproduce, or otherwise disseminate or authorize others to use, reproduce or disseminate such works without prior consent from the Embassy.

V. Safety

The Supplier shall, at his/her/their own expense, be solely responsible for protecting its employees, sub-Photographers, material suppliers, and all other persons from risk of death, injury or bodily harm arising from or in any way related to the photo coverage services or the site where it is being performed.

VI. Terms of Payment

Payment shall be made within seven (7) days after fulfillment of the contract. The Embassy shall deposit the payment to the Supplier's bank account with the following details:
