Terms of Reference

The Embassy of the Philippines intends to engage the services of a professional photographer ("Supplier") to cover the launch of the 75th anniversary of the establishment of the diplomatic relations between the Republic of the Philippines and the Republic of Korea on 05 March 2024.

I. Deliverables / Expected Outputs

The Supplier will produce a database with at least *fifty* (50) high resolution, edited/retouched photographs delivered either via FTP or USB. Photographs should include:

- A. The Ambassador and Embassy officials receiving the guest of honor and other distinguished guests at the event
- B. Delivering of toast remarks and other speeches by the Ambassador and the guest of honor
- C. Other vital moments to be communicated by the Embassy to the Supplier before the date of the event.

Aside from the edited photos, the Supplier shall include in the FTP or USB all of the raw/unedited photos taken during the event.

II. Eligibility / Qualifications of the Supplier

The Supplier should have:

- A. Exceptional photography skills
- B. Excellent photo editing skills
- C. Ability to adhere to deadlines and flexibility
- D. English skills will be an advantage

III. Copyright and Intellectual Property Rights

In consideration of the fees paid, the Supplier expressly assigns to the Embassy any copyright arising from the works of the supplier produces while executing the contract. The Supplier may not use, reproduce or otherwise disseminate or authorize others to use, reproduce or disseminate such works without prior consent from the Embassy.
