

# CONTRACT

The Contract for Master of Ceremonies during the launch reception of the 75<sup>th</sup> Anniversary of the Establishment of the Diplomatic Relations between the Republic of the Philippines and the Republic of Korea ("Contract") is entered into between the **EMBASSY OF THE REPUBLIC OF THE PHILIPPINES** in Seoul ("*Embassy*"), with its office at 80 Hoenamu-ro, Yongsan-gu, Seoul 04346, represented by Ambassador Maria Theresa B. Dizon-De Vega, and **DAHAE CHLOE JUNG** ("*Supplier*"), with its residence at #603, 6 Worldcup-ro 34-gil, Mapo-gu, Seoul, (jointly known as "*Parties*")

## ***I. Term***

The term of this Contract shall commence on 05 March 2024 (Tuesday) and terminated after the conclusion of the event. The even details are as follows:

- a. Name : Launch Reception of the 75<sup>th</sup> Anniversary of the Establishment of the Diplomatic Relations between the Republic of the Philippines and the Republic of Korea
- b. Venue : Namsan I & II, Grand Hyatt Seoul, 322 Sowol-ro, Yongsan-gu, Seoul
- c. Schedule : 05 March 2024 (Tuesday), 6:20 P.M. to 8:20 P.M.
- d. Number of Persons : 120 persons

## ***II. Scope of Work***

- a. Supplier shall provide her services in a competent manner, arrive and perform on 05 March 2024 (Tuesday), as agreed between by the Parties, abide by all reasonable rule and requirements that the Embassy shall make (e.g. bilingual hosting, English and Hangul), and as long as Supplier fully perform its obligations hereunder.
- b. The Embassy shall provide the English script to be delivered by the Supplier during the event.
- c. The Supplier shall likewise translate the provided English script to Hangul for bilingual hosting.

## ***III. Publicity and Recording of Events***

- a. The Supplier agrees to provide or pose for customary and usual photographs to be used for publicity
- b. Where the Supplier's performance at an event is recorded, in whole or in part, the Supplier hereby releases the Embassy to use such recording for its archives only. If an Emcee's performances are recorded for other purposes, the Embassy agrees to obtain an additional release from the

Supplier prior to the use of any such recordings.

**IV. Emcee Service Fee**

The Embassy will charge the service fee ("fee") for the provision of its emcee services performed by the Supplier as indicated in the contract amounting to KRW 1,000,000 (VAT excluded).

**V. Terms of Payment**

Payment shall be made within seven (7) days after fulfillment of the contract. The Embassy shall deposit the payment to the Supplier's bank account with the following details:
