

CONTRACT

The Short-Term Contract for One (1) Interpreter for the Ramon Magsaysay Award Foundation Events on 22 and 23 April 2025 ("*Contract*") is entered into between the **EMBASSY OF THE REPUBLIC OF THE PHILIPPINES** in Seoul ("*Embassy*") represented by Ambassador Maria Theresa B. Dizon-De Vega, and Ms. **SOOYEON ELLENA KIM** ("*Interpreter*").

I. Scope of Work

The Embassy shall employ the services of an Interpreter, as an independent contractor, and shall provide consecutive interpretation, through bilingual hosting, for the Embassy and the members of the Ramon Magsaysay Awards Foundation during the program for the following events:

- i. 22 April 2025 – Magsaysay Laureate Exchange and Reunion
- ii. 23 April 2025 – Youth Dialogue titled "Growing Together for a Better Asia – Promoting Youth Mental Health in the Digital Age"

II. Details of the Contract

III. Qualifications

- a. Based in Seoul, ROK.
- b. Proficient in English, both written and verbal.
- c. Ability to cope with pressure and work in a multicultural environment.
- d. Carry out any other duties as may be assigned.

IV. Confidentiality

All knowledge and information expressly identified by the Embassy in writing as confidential, which the Interpreter acquires during the term of this Contract regarding the business of the Embassy, shall be maintained in confidentiality by the Interpreter, except as expressly authorized by the Embassy in writing. It shall not be divulged or published by the Interpreter and shall not be permitted by the Interpreter to be divulged or published by others.

V. No Employer-Employee Relationship

Nothing in the Contract is intended or shall be deemed to create any employment, partnership, agency or joint venture between the Embassy and Interpreter.

VI. Contract Price

The Embassy agrees to pay **Nine Hundred Forty Thousand Korean Won** (KRW 940,000) for the interpretation services on 22 and 23 April 2025, from 2:00 PM to 5:00 PM.

If the actual hours of service rendered exceed the agreed schedule, the Embassy shall pay the Interpreter's overtime charge of **Seventy Thousand Korean Won** (KRW 70,000) per hour or per fraction of an hour.

VII. Terms of Payment

Payment shall be made within seven (7) days after fulfillment of the contract. The Embassy shall deposit the payment to the Interpreter's bank account with the following details:
